CONSIDERATION OF MINUTES AND ATTENDANCE OF PREVIOUS MEETING

GMRC Secretary James Addison asked for any comments or a motion regarding the minutes and attendance report for the July 31, 2025 Council meeting. Doug Wayne made a motion to approve the minutes as written and Ron Matheson seconded. The motion passed unanimously.

REPORTS

Chairman's Report

GMRC Chairman Courtney Umbehant reported that he recently attended the GARC Policy Official's meeting in Macon with Executive Director Feldman. Mr. Umbehant will also be attending the GARC Annual Conference in November with fellow GMRC Officers, Ron Matheson and James Addison, as well as GMRC Department Heads. Information Services Director Faith Bryan will be speaking at the conference.

Executive Director's Report

Executive Director Feldman announced that Brandon Carlock, who currently serves as GMRC's GIS Technician, has been promoted to GIS Analyst. GMRC will merge its Planning and GIS Departments.

Mrs. Feldman reported that Keep Georgia Beautiful has a funding opportunity available through their BRACE Grant Program. The purpose of the program is to reduce litter, blight, and illegal dumping on public property and encourage code enforcement efforts. Funded through the Solid Waste Trust Fund (SWTF), the grant program is designed to aid Georgia communities to address these challenges. Applications are due October 10, 2025. Health Insurance Plan Change

Executive Director Heather Feldman explained to the Council that GMRC was notified that Cigna would not be offering small group health plan renewals; therefore, GMRC's current plan would no longer be available after 01/31/2026. GMRC would like to offer a similar plan through a level funded Cigna Open Access Plan.

The plan being presented is a level funded POS 80/20 plan with a \$2,500 deductible and would also remove the age-banded rates that GMRC is seeing with the current plan. Changing plans now will allow GMRC to lock in these rates until 10/01/2026 instead of a high probability of increasing when the current plan expires in January 2026. The Cigna Level Funded plan would go into effect beginning on October 1st.

Chairman Umbehant asked for a motion to approve GMRC changing healthcare plans to the Cigna Level Funded Open Access Plan. Kevin Herrit made the motion, and Bill Chafin seconded the motion. The motion passed unanimously.

401(k) Trustee

Executive Director Feldman explained that GMRC has two trustees for the 401(k) Plan – herself and Faith Bryan. Due to Ms. Bryan's upcoming retirement, GMRC will need to name a secondary trustee on the plan. GMRC would like to name Adam Hazell as the secondary trustee.

Chairman Umbehant ask for a motion to approve the resolution removing Faith Bryan and adding Adam Hazell as a trustee on the GMRC 401(k) Plan. Craig Bryant made the motion, and Bill Chafin seconded it. The motion passed unanimously.
