GEORGIA MOUNTAINS REGIONAL COMMISSION COUNCIL MEETING

November 13, 2025

MINUTES

The GMRC Council held its regular monthly meeting on Thursday, November 13, 2025 at 6:00 p.m., at the Towns County Recreation & Conference Center, 150 Foster Park Road, Young Harris, GA 30582. The meeting was hosted by Towns County.

CALL TO ORDER

GMRC Chairman Courtney Umbehant called the meeting to order at 6:03 p.m. and thanked Towns County for their partnership with GMRC.

WELCOME/INTRODUCTIONS

Towns County Recreation Department Director Stuart Nichols welcomed all to Towns County on behalf of Sole Commissioner Cliff Bradshaw. PROGRAM

Clay Pilgrim of Rushton explained that they were only able to present a Draft GMRC FY25 Audit Report at the time of the meeting as the Office of Management and Budget must issue a compliance supplement prior to the audit being finalized. Since the government had been in a shutdown, Rushton was unable to obtain the compliance supplement. However, Rushton does not anticipate that the compliance supplement will change the results of the audit findings. Mr. Pilgrim also reported on the GASB reporting changes that would affect local governments in future audits.

The intent would be to create around 100 new apprenticeship positions throughout the region.
